

### **Delayed Registration of Report of Marriage**

1. Personal appearance of both contracting parties
2. Four (4) copies of typewritten Report of Marriage Form with original signature
  - Please use black ink pen only
  - Entries must be in CAPITAL LETTERS
  - Erroneously filled-out forms will NOT be accepted
3. Original and Three (3) photocopies of the Marriage Contract (with English translation) attested by the UAE Ministry of Foreign Affairs
4. Four (4) pieces passport size photos of each of the contracting parties
5. Three photocopies each of the contracting parties' valid passports
6. Affidavit of Delayed Registration (if applicable)
7. Negative Certification of Marriage Record from PSA (if applicable)
8. Other necessary requirement/s requested by the processor to determine proof of citizenship, identity or eligibility for registration of marriage under Philippine Laws.

#### Payment:

- 100AED for attestation
- 100AED for Report of Marriage
- 100 AED for Affidavit of Delayed Registration

#### Releasing:

- After five (5) working days, the Report of Marriage may be claimed.
- Processing time: 8:00 AM - 12:00 NN
- Releasing time: 3:00 PM - 5:00 PM
